Faculty of Arts and Science

- Instruction will be predominantly in-person for the fall term.
- However, for the first two weeks of the semester students will be permitted to attend classes online. After September 23, all classes marked as in-person will proceed entirely in-person. Students looking to request this accommodation will be contacted by the instructors of their courses near the start of the semester. [[Source](#)]

Faculty of Architecture, Landscape, and Design

- Instruction will be predominantly in-person for the fall term.
- If students are unable to return to campus in time for the start of the semester due to extenuating circumstances, the Office of the Registrar and Student Services will evaluate applications to virtually attend the first two weeks of classes on a case-by-case basis. [[Source](#)]

Faculty of Applied Science and Engineering

- Instruction will be predominantly in-person for the fall term. [[Source](#)]
- If students are unable to return to campus in time for the start of the semester due to extenuating circumstances (e.g. travel restrictions), they should inform the Faculty by completing the Late Return to Campus form, which will be open until September 1. Faculty of Dentistry

Ontario Institute for Studies in Education

- Instruction in the fall term will remain online except courses that require field placements. There are plans for 60% of courses to be in-person in the Winter semester. [[Source](#)]

Faculty of Kinesiology and Physical Education

- 1st and 2nd year students will attend courses delivered online. Upper year students will attend a combination of in-person and online courses. [[Source](#)]

Faculty of Law

- Instruction will be predominantly in-person for the fall term. [[Source](#)]
