March 2022 Report of the Vice-President, Public & University Affairs

Ballis stated that many things have happened since she wrote her Executive Report. She highlighted the VOICES Through the Arts showcase and protest happening as part of the Students For Survivors campaign, which she and Gharbiyeh were working on alongside the FMUA and The PEARS Project. In addition, she highlighted Unity Ball and thanked those in attendance for their support. She stated that UTSU'S Got You is ongoing in the Student Commons from 11:00-17:00 every day, and noted that there is an accompanying scavenger hunt. She stated that she and Sharma were working on acquiring phone chargers for the Student

Commons, as well as a booking system for study spaces. She stated that she had been working with the CRO on elections, and highlighted the transition work and presidential by-elections.

Gharbiyeh also highlighted the Students For Survivors campaign and the Dining Hall Food Insecurity campaign, which concerns the changes in pricing models and lack of accommodations for students in on-campus dining halls. He stated that they had been working on a submission for the University budget, which included recommendations such as increased funding for the Sexual Violence Prevention & Support Centre and more financial aid for international students. He stated that he had also been developing a policy on international engagement, so that the UTSU doesn't alienate any members of the student body when dealing with international politics.

DISCUSSION

Ballis stated that this was an annual adjustment that reflected the results of the past election's referenda.

Sharma reiterated that this was an annual adjustment. He stated that the first fee is the society fee, which is determined by the University and correlates with inflation. He noted that not all the fees are being increased, as some of them are required to remain static. He highlighted the 3% increase in the Health & Dental Plan fees, and noted that the Health & Dental Plan costs are locked in for the next two years. He also highlighted the Student Commons Capital fee and the Operating levy, which are both collected to support the continued operation of the Student Commons. He noted that the Student Commons is expensive to run, and that they pay the University a maintenance fee. He stated that other fee increases are consistent with inflation.
